She is jointed general editor of the *Corpus Philosophorum Graecorum Recentiorum* and has edited *Kythera: Myth and* 

Reality (Kythera, 5 vols., 2003) and Vita Contemplativa, Essays in Honour of Demetrios N. Koutras (Athens, 2006) She has also given papers in numerous conferences and has published widely in journals and collected volumes in Greek, English and Italian.
